But in writing thus, I do not for a moment wish you to understand that I have any doubts of conscience respecting the substance of my ministry or the slightest wish to modify those statements of Gospel truth, to which you have been accustomed to lend a willing ear, for in this respect I can truly affirm that I have not shunned to declare unto you, all the counsel of God; Those great truths so unflinchingly proclaimed & so surely believed amongst us - such as the Electing love of God the Father, the substitutionary obedience of God the Son, and the efficacious grace of God the Spirit, - as ensuring to the weakest believer in Jesus a full free & everlasting salvation, - together with the perfect warrant which the Gospel affords to the very chief of sinners, to lay hold on Christ & all his saving benefits - these Dear brethren are doctrines precious to me as ever, constituting the only foundation of my own hope of eternal life, & the great principles on which I trust my future ministrations will ever be conducted.

Should it be given me again to preach the word of life amongst you, I have no new doctrine to propound nor any old doctrine to modernize, Christ & his Cross must still be all my theme, and to present every one of you perfect in Christ Jesus must still constitute the scope and end of all my labours. Praying exceedingly in it Dear brethren to your absent Pastor, to hear that you continue to strive together in your prayer to God on his behalf. May these earnest pleadings prevail, &

especially so far as they relate to the more entire
 sanctification of his heart, & the joyous consecration
 of all his energies to the service of your common
 Lord! I trust that through your prayers I shall
 be given to you again. This however is at present
 a matter on which I find it impossible to speak
 with certainty. We are mutually in the Lord's hands
 & may we have grace to be still; then shall we
 assuredly find that He is "God - even our own"
 "God, who doth not afflict willingly," & who amidst
 the darkest dispensations of His providence, will
 "ever be mindful of His Covenant." To the
 loving care of the God & Father of our Lord Jesus,
 I would most affectionately & devoutly commend
 you, & that a sensible portion of the Spirit's saving
 influence may rest upon all who preach the unsearch-
 -able riches of Christ in your assemblies, & upon all
 who listen to the reconciling word! What more
 appropriate petition can your absent Pastor offer
 than this that great grace may rest upon you all?

Resolved 1.st That while the statement of our beloved Pastor has produced in our minds sincere regret that the present state of his health should have rendered him in any degree incompetent for the discharge of his ministerial duties - we feel it to be incumbent on us to bow to the Divine will and our imperative duty to cherish the remembrance of the years during which his ministry has been so eminently acceptable profitable and prosperous. - and moreover to record on this occasion our devout gratitude to the Great Head of the Church for the distinguishing favour vouchsafed to us as a Christian community in connexion with the existing pastorate.

Resolved 2.nd That affectionately sympathizing with our esteemed Pastor under the circumstances in which he is placed, we very cordially concur in the views he has expressed respecting the desirability of seeking a regular Assistant in his ministerial work, and earnestly pray that the Lord may

prosper his endeavours to secure the services of a good minister of Jesus Christ."

560 A communication was read by our pastor from Dr. Crisp of Bristol - suggesting that in any application that might be made to the Comm^o of the Bristol College with a view to secure the services of Mr. Stürmer it would be desirable that something more should be proposed than the invitation of Mr. S. as an assistant minister - & intimating that unless such invitation embraced the future pastorate the sanction of the Comm^o was not likely to be secured. A letter from Mr. Stürmer to the same effect was also submitted to the church. After free discussion it was unanimously

'That while cherishing every feeling of respect & esteem for our friend Mr. Stürmer, and cordially uniting in the wish that he should accept the office of Assistant Minister - we do not regard ourselves as being in a position

to offer any opinion on the question mooted in his letter. Our pastor then read the reply which he proposed sending to the letter of Dr. Cress - of which reply the church unan^{ly} approved.

Minutes of Special Church Meeting

held Nov. 2nd 1857.

The Resignation of our esteemed Pastor having been received by the Deacons, was read ^{to} the meeting, and is here recorded.

To the Church of Christ assembling in Salem Chapel
Dear Brethren in Christ,

The time has come when I feel it to be a clear call of duty to resign my pastoral office amongst you - and acting on this conviction I would affectionately signify my intention of closing my ministry at Hitchin with the present year.

In terminating a connection at once so sacred & so endearing, and which in our own case had witnessed such constant and manifest proofs of Gods rich blessing, it is no slight cause for thankfulness to remember that the present necessity has not originated in any alienation of affection between pastor & flock but in causes altogether independent of human control. And if a yet stronger incentive to gratitude were needed, surely it presents itself in the fact that God has already brought amongst you a truly gracious & gifted young man upon whom all eyes & hearts are naturally turned as an eligible successor in the pastorate.

In my impaired state of health I could not have anticipated any very lengthened retention of the pastoral office - it would however be most affectionate to deny

that recent events have precipitated my retirement. —
 calm and prayerful reflection satisfies me that this is a
 sacrifice which the peace & prosperity of the church
 demand, & after some sharp struggles I can now calmly
 say "The will of the Lord be done"! And now beloved in
 Jesus let me beseech you to accept this resignation in
 the same spirit of self-sacrificing acquiescence in the will
 of the Lord, & influenced by the same earnest desire to
 keep the unity of the Spirit in the bond of peace. —

I need not say that wherever God may direct my steps
 you will ever live in my loving & prayerful remembrance
 may I not also cherish the hope that amidst the excitement
 of a new order of ministrations & the more abundant blessing
 which I trust may distinguish it, you will sometimes
 think kindly & graciously of one who was permitted to
 spend his best days in your fellowship, & to consecrate
 his best energies to your spiritual advancement?

That the blessing of our Covenant God The Father
 the Son & the Holy Spirit may rest upon you all —
 and that when Christ who is our life shall appear we
 may all appear with Him in glory — is the sincere
 prayer, Dear Brethren

 the deepest regret on the part of the church it was

to anything rather than the peace and prosperity of the Church.

The Deacons were requested to convey the above Res. with an appropriate Letter expressive of the unfeigned grief and concern manifested at this meeting.

The Deacons having informed the Church that they had not succeeded in inducing Mr. Wood to recall his Resignation, it was

Resolved unanimously, that the Resignation of our beloved Pastor (after reiterated requests by writing and otherwise, that he would reconsider an act so painful to all our minds,) be accepted; at the same time the Church desired to record its unfeigned gratitude to God for his faithful ministrations during a period of nearly seventeen years, and on which His rich blessing has so manifestly rested; earnestly beseeching Him to overrule an event which we can but deplore, for the purposes of His own glory, and enable us meekly to bow to His sovereign will, and provide us with a Pastor after His own heart, while we affectionately commend ^{to} His special guardianship and favour, our late Minister, trusting he may yet be spared to labour in some other sphere as successfully as amongst us, and that finally he may have awarded to him a crown of life.

A suggestion having been offered at a previous Meeting of the Church & Subscribers that a Testimonial be presented to Mr. Broad as a mark of respect & esteem it was Resolved that the Collectors meet on Monday evening next as a Committee with power to add to their number, with a view to carrying out this object.

A Legacy of one Hundred Pounds having been left to the Poor of the Church and Congregation by the Late Mr. Godwin, a Sea Meeting was appointed to be held on Thursday December 10. 1857 to distribute the same, when the following Persons received the aftermentioned sums each, viz.

Church Meeting Dec. 16. 1857

A Letter from Mr. Sturges (concerning the Invitation of Church), was read to the Church.

On the 19th December a Tea and Coffee service was presented to the Rev J Broad and a purse containing 10 £ to Mr. Broad accompanied by the following letters by direction of the committee

To the Rev. J Broad from the Church and Congregation belonging to Salem Chapel Hitchin.

Dear Sir In presenting you with a Silver Tea service, on your retirement from the Pastoral Office among us, we feel that this token of our esteem will very inadequately convey our sense of the privileges enjoyed by us under your ministry, nor can we fully express the deep sense we entertain of our loss in your removal from a sphere of labour where it has pleased God to crown your efforts with such signal success. These slight memorials the tribute of affection though frail & perishable may at times help to remind you of those in whose hearts you will live while memory lasts. With us you leave a more substantial monument to your zealous and valuable labours, in the commodious Chapel in which we are permitted to worship, commenced at your suggestion (and completed under peculiarly favourable circumstances in the early part of your ministry, it will long be hallowed by evocative associations in connection with those who have there been brought to the knowledge of the truth as it is in Jesus through your instrumentality. Although the time will come when there shall not be left of it one stone upon another, yet while we assemble there for the worship of our common Lord and Father, we shall

often be reminded of the faithful and affectionate appeals
 and the effectual fervent prayers that there have been offered
 by you for our spiritual welfare. — If things subject to
 decay are invested with a power to fix our thoughts intently on
 the past, the present, the future, with how much greater delight
 may we look forward in the belief that the benefit of your labours
 may be extended to the end of time, and that generations yet un-
 born may be blessed through the instrumentality of those to
 whom your ministry has come with power from on high. —
 We would not forget that 'Paul may plant and Apollus water
 but the increase is of God', yet we rejoice in the thought that
 the heavenly seed which has been sown by you, has under God
 been blessed to many souls, and knowing that it has been planted
 with your fervent prayers, and watered with your tears, we
 may confidently look for the fulfilment of the promise that
 'He that goeth forth and weepeth bearing precious seed shall
 doubtless come again with rejoicing, bringing his sheaves
 with him'. — While a painful feeling of regret per-
 vades our minds at the severance of that bond that has
 united us as pastor and people, it is highly satisfactory to
 know, it is not the consequence of any diminution of interest

 your affliction, we earnestly hope that some other sphere
 of usefulness may be opened for you, more compatible with
 your impaired health, and its restoration be thus promoted.
 Wherever your lot may be cast, rest assured our prayers and
 best wishes will follow you, that you may lie down in green
 pastures beside the still waters, and that goodness and mercy
 may follow you and your dear partner in life and beloved children
 all your days. — It is reason for grateful praise
 that you have been spared to us so long, we are conscious
 that our profiting has not corresponded to our opportunities

And now you are about to be taken from us, it may be well to ask ourselves if we have not depended too much on your instrumentality and too little on Him who alone could make it efficient. If by such enquiry we are led to seek more earnestly for help from above, even your removal, much as we may deplore it at present, may be for our good. That every blessing may rest on you and yours, is the sincere prayer of the Church & Congregation under your pastoral care at Salem Chapel, Hitchin.

597 Christian Friends

I accept the Pastorate among you to which so kindly & heartily you have invited me, In doing so I have not failed to exercise both prayer & patient thought. It would have given me pleasure had the invitation been perfectly unanimous & the fact that it was not so has been only weighed by me. Still I should not have ^{felt} justified, (notwithstanding all my appreciation of the friends dissenting to have declined on that account. And now with the

conviction that the finger of God points the way
I cheerfully & tremblingly follow where it leads,
May the decisions of the great day satisfy the
rectitude of the step now taken,

In coming among you I entertain the hope
of doing good. By a spirit of Christian charity, by
living the gospel as well as preaching the gospel,
by an earnest, though loving, enforcement of the whole
counsel of God, by constancy of prayer & Diligence
of effort (God helping me) I would fain hope to
commend myself to the consciencess of all, & all
Brethren in the mission that has been assigned to
every Christian & every Christian minister against
the Prince of this world & the power of darkness,
there will be difficulties, difficulties in which I
shall require your sympathy, difficulties in which
I must ask your aid. Let me ask of you and
all to bear me on your heart before God in prayer,
not only in the Sanctuary, but in the closet & at the
family altar, Accustom your children to pray for me
'Brethren pray for me'. Though I trust on further
acquaintance with me, I may prove not without
claims upon your respect as well as love. you
must remember that I am a man of like passions
as yourselves, compassed with infirmity & prone to
sin. And if an Apostle feeling this, was among
those to whom he ministered, in weakness & fear
much trembling, how much more should I?

'Tis not a cause of small import The Pastor's
care demands. His sufficiency must be of God
for it is no where else. But you can aid me in
prayer to acquire that sufficiency. & the

consciousness that my people are urgent with God for a blessing on my labours will cheer me in the belief that that blessing will be given. May I urge upon my friends what at all times is suitable, a greater attention to the study of the Bible? In any difference of judgment that may occur, let us all repair meekly and humbly to the Bible, - The Bible & the Bible only must be the religion of Christians. In assuming the office of Christian Teacher among you I do not for a moment suppose that I am universally acquainted with that Sacred Volume. There are depths in that most precious Book, which have not yet been sounded by mortal line and I am not infallible. Let us all then make that the standard of our authority. And when we come to it, let us come not with preconceived opinions, not to prove ourselves right or to establish a theory, or to prove an argument, but to ascertain the mind of the Spirit; With a childlike disposition, depending upon the Divine Spirit for instruction let us pray "Open Thou mine eyes O Lord that I may understand the wondrous things contained in the law." I am not able positively to state the time when I may commence my Pastorate at Mitchin, my stay at Dymouth is delayed longer than I expected & I may require a week or two at the close of it. You shall hear again on that matter but most likely (I think) I shall come to you at the beginning or in the early part of February.

May God bless you my dear friend with the light of His countenance & give you peace.

800 At Intermediate Church Meetings held 16th January our Young Friend Julia West was received to fellowship on the recommendation of Messengers: & on the 23^d of January. The Pastor proposed Carrie Penn & was requested to apply for the Transfer

from the Church assembling at Union Chapel, Sutton of Eliza Law

At the Church Meeting held Thursday 2^d Feb. 1865 business was introduced in the usual way by prayer & reading the minutes of the previous meeting

801
Messengers appointed to visit the Candidates Emma Palmer, Amy West, & Carrie Penn reported satisfactorily. On their written communications being read it was agreed to receive them to fellowship.

802
A letter was read from the Deacon of the Baptist Church, Foston, Gosport requesting the transfer of our Brother James Newbald who after an education received at Regents Park College London had been chosen unanimously of the Pastor of the aforementioned Church. Resolved on a motion by Bro: Goddell & seconded by Bro: Shadwell that the Pastor be requested to write a note transferring our Bro: Newbald expressing our high esteem of our young Friend & our earnest prayer that he might become through a long & useful life as he promised to be a good Minister of G. O. & Secs.

803
The Pastor was requested to apply for the transfer of Janney here from the Bap: Church Dover.

804
The Pastor proposed for fellowship George Newling. Visited his Brethren Woodfield & Chambers.

The letter from Sutton dismissing Eliza Law not yet arrived.

The Church met again on Thursday 2^d March when business was introduced in the usual way.

805
A satisfactory letter was read transferring Eliza Law: also one transferring Janney here

806
The Deputation requested to visit George Newling reported

satisfactory & on his written communication being read it was agreed to receive him to fellowship.

807 The Pastor read a letter from our Brother Johnson calling attention to the need of volunteer assistance in showing strangers to seats in the galleries of greater order & quietness during prayer & increased accommodation for the S. School children in the Gallery & also of some more effectual means of warming the Chapel & School Rooms.

808 It was agreed to accept the help of Brethren Morgan & James on the one side & Chambers & Reeve on the other side of the Galleries. The importance of order in prayer was admitted & to meet the remaining suggestions a Com.^{tee} was appointed consisting of Brethren Johnson, Lloyd, R. Lane, N. Foster & Wm. Foster, the Pastor & Deacons inclusive to consider the advisableness & practicableness of further measures & report accordingly.

Church Meeting, Thursday 30.th March 1865.

The Minutes of the last Ch. Meeting were read & confirmed.

809 The Report of the Com.^{tee} for effecting improvements in the Chapel adjourned; meanwhile advantage to be taken of the Good Friday Tea Meeting to get the feeling of the Congregation on the subject.

810 The Pastor read a letter from Mrs. Frost (late Hannah Anderson) applying for re-admission to fellowship: testimony was given to her repentance & of her present & continued consistency & it was agreed to re-admit her - with the recommendation that she should seek transportation to a Church nearer her present residence.

Church Meeting Thursday 27.th April 1865.

The Minutes of the preceding Church Meeting were read & confirmed.

811 The result of the Meeting at the Good Friday Tea was reported to be notes favourable to the proposed alterations as had been anticipated.

812 It was resolved to adjourn the matter & to call a special meeting on

the return of the Pastor & prior to another monthly Chancel Meeting. In the meantime the feeling of friends still further to be ascertained.

813 The Incidental Accts. now reported as audited & found correct & were then passed.

Church Meeting Thursday 1st June 1865.

The Minutes of the preceding Church Meeting were read & confirmed.

814 The Pastor read a letter from Stella Freuder intimating that she had lately been worshipping with a company of Plymouth Brethren & expressing her wish no longer to be considered a member of our Communion. The Pastor reported his correspondence with her on the subject & it appearing still to be her wish it was complied with.

815 A letter was read from the Baptist Church at Stoke Newington London requesting the transfer of our sister Mary Leonard - an honorable transfer was given.

816 A letter was read from the Stacms of the Church at Mlodbury Devon requesting the transfer of our Brother Amos English (recently the Pastor elect of that Church) & of Sarah his wife. An honorable transfer was given in which the usefulness of our Brother's labours in the Villages surrounding Kitchin was recognized & in which were expressed earnest desires for our Brother's success in his new sphere.

817 The Pastor was requested to apply for the transfer of Jane Searke from the Baptist Church, Buckland, Devon.

818 The Pastor proposed for fellowship the following Candidates
Louisa Parker Visitors Brethton Lane & W. Foster
Emma Gibbs " " Madwell & Ardwell.
Henry Kido " " Johnen & Henn.

819 The question of alterations in the Chapel was passed sub silentio, the Brother who was alone able to report on the finances of the matter not being present.

Church Meeting 6th July 1865. After prayer the Minutes of the preceding Meeting were read & confirmed.

820 A letter was read from the Baptist Church at Buck^l. Monachorum dismissing Anne Sawkett & was unanimously received.

821 The Deputies requested to visit Candidates proposed at the last Church Meeting reported satisfactory written communications of great interest were read from two of the three & it was unanimously agreed to welcome them all to fellowship.

822 The subject of proposed alterations having been received it was moved & seconded that the Brethren named as a Com^{tee} in Minute 808 should meet again to consider the subject. Bro Brother Kelsey to be added to the number.

823 An intervening Church Meeting had been held (at which the Pastor was not present through relative bereavement) to consider a proposal from the West Union Com^{tee} to hold a Conference on the Evangelization of the County & to appoint delegates to that Conference. Our Brethren Kelsey & Wm Foster attended as delegates. The result of the Conference to come before us in a Circular which it was agreed to send to the Churches in the County.

824 Rumours having been widely circulated as to the immoral conduct of Mrs. Saunders (late Lavinia Law) & two of the Deacons having agreed to investigate the subject it was reported that such rumours were true & our Brethren recommended that we should withdraw from her fellowship. This was accordingly done & a note to that effect addressed to Mrs. Saunders by the Pastor.

823 A letter was read from the Rev. S. Pugh of Leamington requesting the transfer of our Sister Mrs. Wilson (late Eggleston) to the Church of which he is Pastor. An honourable transfer given.

Church Meeting 27th July 1865. The Minutes of the previous Meeting were read & confirmed.

824 The Pastor submitted to the Church the recommendations of Brethren referred to in Minute 822

1st That the subject of warming the Chapel be for the present referred.

2^d That the Chapel be ventilated by four Ventilators in the ceiling, at the corners & within the porch at the Entrance of the Chapel doors be placed to prevent the draft & mitigate the cold.

3^d That the proposed alterations in the Galleries be dropped. These recommendations were adopted by the Church.

825 The Pastor proposed Mr. Arthur Duggan for fellowship. Reputation, Brethren Madwell & Bodwell.

Church Meeting 31st August '65. The Minutes of the previous Meeting were read & confirmed.

826 It was reported that the alterations of the Chapel, approved by the Church & recorded in Minute 824, were already in the hands of Brethren Foster & Lane

827 The Brethren deputed to visit our Brother Arthur Duggan reported satisfactorily: his written communication was read & it was agreed by the Church unanimously to welcome him to fellowship.

828 The Pastor proposed Mrs. Kitken for fellowship. visitors Brethren Madwell & Bodwell.

Church Meeting 2^d Nov^r 1865. The Minutes of the previous Meeting were read & confirmed.

829 The Brethren deputed to visit Mrs. Kitken reported satisfactorily & her written communication having been read it was agreed to receive her to fellowship.

830 A letter was read from the Rev. C. St.urgeon, requesting the transfer of our Brother Wm Burton: an honourable transfer was given.

831 A letter was read from the Rev. W. Brock requesting the transfer of our sister Mrs. Valentine late Rachel Cole: an

honourable transfer was given.

832 A letter was read from the Rev. J. R. Johnson of Luton requesting the transfer of our Sister Lydia Mead: an honourable transfer was given.

833 The Pastor was requested to write to the Rev. J. Matthews of Boston for the transfer of our Brother & Sister Mrs. Perry.

834 Our Brethren in the Diaconate having long felt the need of increased help in their duties a resolution was proposed to the following effect - "That it is desirable to elect two additional Deacons & for this purpose at our next meeting the Church is recommended to nominate six Brethren from whom at the meeting next ensuing the desired number should be taken." moved by Brother Soderud & seconded by Bro. Shadwell carried unanimously.

835 Our Bro. Kalsey moved the following Resolution - "That the Church should take the earliest opportunity of becoming possessed of an Organ & that the following Gentlemen belonging to the Church & Congregation should constitute a Com.^o to confer on the subject & to carry out the general wish." Messrs. Juora, Lloyd, Johnson, Bailey, W. Foster, Pyyor, Cruden, Warr, with the Pastor & Deacons. The motion was seconded by Mr. Lloyd adding Mr. Kalsey's name to the Com.^o Carried unanimously.

Church Meeting 30th November. The Minutes of the last Church Meeting were read & confirmed.

836 A letter was read from the Church at Boston honourably dismissing our Friends Mr. & Mrs. Perry. & they were accordingly received.

837 An application was made for the transfer of our Sister Regia Aldrich to the Church meeting at Crown Chapel London: an honourable transfer voted.

838 Before proceeding to nomination for Deacons it was agreed that the mode of election should be by papers, on which members present should write two of the names nominated & to which they should attach their own names. No absentees allowed to vote.

839 The following six Brethren were then nominated respectively, (each nomination being seconded & put to the vote) Brethren Henry Foster, Rich^d. Lane, W^m. Foster, George Hawley, Jno. Malden, & Benjamin Barker.

840 The Pastor proposed Mr. Kitken as Candidate for fellowship - Visitors Brethren Shadwell & Dodevell.

Church Meeting December 21st. The Minutes of the past Church Meeting were read & confirmed.

841 The Visitors requested to visit Brother Kitken gave in their report which together with his written communication was deemed satisfactory & accordingly he was welcomed to fellowship.

842 The Pastor was requested to apply for the transfer of fellowship from Brother W^m. Dred from the Ch: at Breechwood Green to our sister Mrs. Arthur Soggett from that at St. Andrew.

843 The Pastor gave a statement expressing his wish of Ellen Paris to become a member of the Church: he read a certificate of Miss Paris's Membership with a Church at Manchester before her residence in Kitchin & stated his acquaintance with her & her character since that time. It was moved & seconded & agreed that she should be welcomed to fellowship.

844 The election of Deacons was then proceeded with in accordance with Minute 838 the Members present had furnished themselves with voting papers, which the Deacons who acted as scrutineers collected. It was found that the two highest on the list were Brethren H^o. Foster & Rich^d. Lane who were regarded as the elect of the Church.

845 The New Year Tea was fixed for the 1st of January when the Deacons elect it was hoped would testify to their acceptance of office & the Church would make a special blessing.

846 Memoranda. The Annual Meeting was held according to appointment & was attended by a larger number than usual of members. After singing of Prayer the Pastor

called upon Brethren Lane & H. Foster to signify their response to the wishes of the Church, when both in very suitable terms expressed their sense of the honour conferred on them by their Brethren in thus being called to the office of Deacon. Their willingness to comply & their earnest desire for the prayers of the Church that they might use the office of Deacon well. Our Brethren were again commended to God in prayer & gratitude generally was expressed that God had so wisely directed the choice of the Church & so influenced the minds of Brethren to accept it. Both Brethren come from an honored ancestry in the service of this Church.

The Pastor then read a tabular statement of the Members of the Church, from which it appeared that there had been 19 additions to the Church, ^{during the year} of whom 6 were by transfer, 11 by profession or by profession & Baptism & 2 by Restoration: on the other hand there had been a loss of 16, of whom the greater part had been by transfer & 4 by death, leaving only an increase of 3, a smaller number than ever before during the present Pastor's settlement. It was also stated that the number of members' names on the Book was 298 of whom 78 were Males & 220 were females. Attention was also directed to the small number of female members at our Prayer Meetings, & the very large proportion of members whose names were retained though living at a distance & even in localities not known. The agencies of the Church generally were reviewed: & the addresses of the Brethren were practical, & animated by a devout, earnest spirit. It is hoped that good will come of that Meeting.

Church Meeting Thursday Feb. 1st 1886. The Minutes of the previous Meeting were read & confirmed.

Before proceeding to the current business of the Evening the Pastor made a statement to the following effect: that the infrequent attendance of certain Members of the Church upon the public means of grace & ordinances of God's house as established.

among us, had long been to him a matter of deep regret. He was encouraged to believe, that in many respects there had been a great improvement in us as a Church & Congregation. ^(since his coming among us) Still there were Members enrolled with us, who did not obey the Scripture command "not forsaking the assembling of ourselves together" & who caused divisions. (Circumstances of a painful nature had lately occurred which had obliged him to call attention to our Brother James Thorn as long offending in these particulars. (v. Heb. x. 25; Rom. xvi. 17; 2 Thessalonians III. 6.)

Our Brother Chadwell then stated that "at a Meeting of the Deacons of Salem Chapel held Jan. 11. 1866 it had been unanimously resolved - that taking into consideration the spirit & disposition of Brother James Thorn towards the Church & Pastor, they felt constrained to advise him to resign his Membership with the Church, believing as they did his longer connexion with them would not tend to the peace or prosperity of any party." That Res.ⁿ had been handed to Mr. Thorn by the Deacons who urged upon him compliance therewith, but in vain. It was accordingly his duty, on the recommendation of Brother Officers, though with great reluctance of them to move

"That we withdraw from fellowship with our Brother James Thorn & that he be considered no longer a Member with us." This Res.ⁿ was seconded by our Brother John Foster & supported by our Brother Lane & carried with only one dissentient. It was with great reluctance & after long patience the Church came to this decision respecting an elderly & (they still hope) a Christian man.

849 A letter was read from the Pastor of the Indep.^t Church Weymouth requesting the transfer of our sister & niece Plomer - an honourable transfer voted.

850 A letter was read from the Pastor of the Free Church St. Ives Hunts transferring to our fellowship Susan Drane. resolved unanimously to accept it.

851. A letter was read from the Pastor of the Indep.^t Church, Totness transferring to our fellowship Mrs. Arthur Boffett's resolve unanimously to accept it.

852. A letter was read from William Ayre communicating his intention that of his wife to withdraw from our fellowship. The Pastor related the circumstances under which he had recommended to our Brethren this step. The letter was accepted.

853. The Pastor was requested to make application to the Rev. Edwin Bolton Pastor of the Indep.^t Church at Bromley Kent for the transfer of Sarah Burton

854. Memoranda. Whereas a portion of the Burial Ground attached to our former Meeting House remained Copyhold & subjected as to the expense of release to every forty years - & whereas the no. of Trustees in whose names it was held had been reduced to two both of whom were aged men the Deacons after consulting with Friends & under the instructions of a Legal Friend had enfranchised the same. It was then thought advisable, seeing that the Chapel property was held under different Trusts & those Trusts were not in a satisfactory condition to call together the Trustees & to confer with them on the propriety of incurring one expense & amalgamating the Trusts. Accordingly a Meeting was held - November 21st 1865 - present Messrs. Severs,

Kainworth, Jun. Foster (Weymouth) J. B. Seard & Thos. Sedwell (Glasco) the Pastor in the Chair - when the letters of Messrs. Carson & Woodcock were read, the assent of absent Trustees stated & the following Resolutions passed unanimously.

Moved by Mr. Kainworth & seconded by Mr. Seard "that in the opinion of this Meeting the different Trusts of the Chapel & Burying Ground should be consolidated & new Trustees appointed in accordance with the terms of the Trust Deed."

The matter has been proceeded with & the Pastor is requested to enter in the Minutes of the Church the following record of two Meetings (in succession) held on the same evening.

No. of Members deceased 3, dismissed 6, withdrawn & excluded (chiefly for irregular attendance or long absence) 28; making a diminut^{ion} of names on the Church Register of 13 & leaving the no. of Members 278. It was felt though a decrease had been apparently sustained, it was only apparent. For many years the list had not been so clear of merely nominal members & an approach had now been made to appropriate Christ^{ian} discipline. He also mentioned that he was requested in the name of the North Union to offer them \$30 annually toward the support of such an Agent provided an equal or a larger sum were raised by the Ch. at Tiltons Mt. without at present accept^g the offer of the Union. The follow^g Resolut^{ns} was proposed by W. N. Foster & seconded by Dr. Bodwell & carried unanimously.

The subject of the Missionary to the Church was then introduced. & after an account of the weekly off^g was read, it was moved seconded & carried that the Com^{tee} be requested to take measures to procure a Missionary.

The Annual Meeting of the Church was held on Wednesday the 1st January 1868 when a goodly number of friends were present (more especially at the Meeting).

well fare. one soweth and another reapeth. I believe
that by the blessing of God I have sown seed of the
Kingdom which another may reap. But be that as
it may it is my earnest desire that God will

ever bless you and yours. I stand fast in the Lord my
dearly beloved: My resignation will take effect on the
24 of June next. Mrs Short unites with me in
affectionate regards. I am my dear Brother's
in Christ yours in the bonds of the gospel

After you left the church meeting this
evening your letter of resignation was read by Mr Chadwell
I need not tell you with what surprise and sorrow

My dear Sir Fitchin April 1868

I cannot sufficiently thank you and the kind
friends who joined in sending the Resolution

so affectionately conveyed on the 24th. At the same
time I do not see my way to alter my Decision
(and retract my letter of resignation, the circumstances
which led to it remaining the same), with those cir-
cumstances our friends the Deacons are fully
acquainted, as I have had frequent and full commu-
nications with them. though I did not deem it wise
to enter more at length into the nature of those
communications in my letter of Resignation.

It may be necessary now. Several misre-
ceptions are afloat which I think should be cor-
rected and it may spare the necessity of a more public
notice if they are removed at once.

1st. It has been stated I wished to exclude certain
members - in reply to which I wish it to be understood
I have never urged, asked, or even breathed the desire to
exclude a single person, I am not conscious of an
ill feeling to an individual, and only regret I cannot
agree with some from whom I am compelled to differ.

2^{ndly}. It has been stated I have made requests con-
cerning attendance irrespective of distance and claims
of religious services at Village Stations &c. I have com-
mitted no such thing and would appeal to letters and conversation
as proofs. All I have said is If distance sickness
or causes of lawful detention do not prevent, a member
(to say the least) ought to attend more frequently at his
own place of worship than at another.

3^{rdly}. As with regard officious talk I would wish to state
my difficulty has had nothing to do with the question
of its use, that I leave, or would gladly allow
Difference of opinion about, but my difficulty

has respected the origin, the mode in which it was undertaken and has been carried on - and especially the irregularity of attendance on the part of members, and members families, which it involves. Although it should involve the entire transfer of Church and Congregation from Whitehouse Street. I would not lift up a finger to stay it if it were thought to be for the glory of God, but this irregularity whilst membership remains seems thoroughly inconsistent. I should be much obliged to you if you will communicate these things to the Church. In the meanwhile accept my thanks for the interest you have always manifested in me, and for the kind sympathy expressed in Mr. Short's illness.

Church collecting held Aug. 27. 1868.

The former minutes were read and confirmed. It was moved by Mr Woodfield seconded by Mr Morgan, that the Rev. S. C. Aldis be invited to supply the Pulpit at Salem Chapel for four Sabbaths on probation with a view the Pastorale.

Mr Johnson moved as an amendment that the Rev Mr Best be invited to supply the Pulpit on probation but this was not seconded.

Mr Henry Foster having read a statement of the Subscriptions towards the support of the Ministry and the Disbursements, it was moved by Mr Johnson and seconded by Mr W. Foster, that the statement of the pecuniary accounts be approved and passed. After a long conversation on the pecuniary affairs of the Church generally, it was agreed
1st That all Subscriptions towards the support of the Ministry be considered as belonging to the Minister,
2^d That money contributed after the Lords

supper, be given to the poor.

3. That the incidental expenses be made to include the payment of the Supplies during the Ministers Holiday.

At a Church Meeting held Oct. 1. 1868, it was proposed by Mr. Smith Woodfield and seconded by Mr. John Morgan that the Rev. John Aloisius be invited to become the Pastor of this Church.

12 voted for the Resolution, 7 did not vote, none against.

At a Meeting of Subscribers held Oct. 5. 1868. It was moved by Mr. B. Leonard seconded by Mr. John Palmer that the Resolution of the Church inviting the Rev. John Aloisius be approved by this meeting.

58 voted for, 1 voted against, 1 was absent.

The following Letter was sent to Mr. Alois.

My Dear friend

On the behalf of my brethren, I beg now to convey to you the Resolution passed by the Church and Subscribers, both were carried with great harmony and cordiality, and we submit them to your serious consideration, earnestly praying that the great Head of the Church may guide you to a right

decision, as our hope and faith is. We have led us.

I think I need not enlarge much now, should you be led to accede to our request, no effort will be wanting on our part to evince our hearty sympathy and cooperation in every thing that concerns the welfare

of the Church and congregation, as well as to

and leader. It is only right to state that our
Subscriptions for the support of the Minister for
several years past, have averaged 200 £, and
we have no reason to think that the amount will be

and to form a fund for repairs &c, But we hope

The following are Mrs. Davis' replies
To the Church of N. meeting in Salem Chapel. ^{Hickory}
Beloved Brethren & Sisters in N. ^{Market}

There has been transmitted to me, a resolution
passed by you at a Church meeting held October 1st
inviting me to undertake the Pastoral office
among you. In this mark of your confidence &
esteem I heartily thank God, & thank you, &
now I write to signify my acceptance of your
invitations. It is with mingled emotions that I
do so, the thought of tearing myself away from the
endearing relationships and hallowed associations
of my work in New York, is very painful, especially
as I find that it gives pain to many. And I
experience some trepidation at the prospect of

196

entering upon so important a post, & so arduous a
 work, but on the other hand my deliberate conviction is
 that it is the path of duty; & I therefore desire to
 exercise trust for the rest. Many circumstances combine
 to lead me to this conclusion. I could not but be
 gratified by the very kind & cordial reception I
 received from so many during my visit, which seems
 to me an earnest of a happy & useful association
 with you. again, the large congregations I witnessed
 greatly encouraged me; though I cannot reasonably
 expect that they will continue as a constancy what
 they were during an occasional visit. Moreover, the
 remarkable unanimity & apparent earnestness of the
 invitation seem to me to be a striking proof that
 God's hand is in it, besides I felt from the first that
 the sphere of labour presented is remarkably congenial
 to me. Further those whom I have consulted are
 unanimous in the belief that it is my duty to comply,
 even some whose feelings & wishes would lead them to
 an opposite conclusion, but I rely especially on this
 decision as one that has been arrived at after much
 earnest prayer for evidence on both sides, & God
 is the hearer of prayer. Thus I accept your invitation
 with a good degree of confidence that it is the Lord's
 appointment. What the result may be is known
 only to Him who reads the future, but I breathe
 the prayer & venture to cherish the hope that the union
 thus consummated may continue for many years,
 fraught with blessings to many, & bringing glory to God.
 It will always be my aim to cherish & trust
 it may be my privilege to enjoy the most cordial

relations with those who have been chosen among you to the honourable office of Deacons. And as during nearly 15 years I have never had a jarring word with one of the Deacons in New York, I have no fear in this respect for the future. Their office and themselves I trust I shall always hold in honour. I regard my pulpit ministrations as my most important work; but shall endeavor to engage in domiciliary visitation as much as is practicable. But I must beg you not to be unreasonable in your expectations in this matter. It will also be my desire to assist & encourage as far as my strength will permit the Sunday School, the preaching Stations & any other agencies among you to do good. Some few among you are doubtful of the wisdom of the step now taken. I am thankful that they are only doubtful & not convinced that it is unwise or they would have opposed my coming. But though they do not find my ministry is of a kind to meet their want I trust I may be able so to act as at least to win their respect & that the result may prove the wisdom of the decision of so many.

I think it desirable to state that owing to bad sight I am very slow in remembering & recognizing faces; as that I fear it will be some time before I can know all the members of the church I mention this lest that should be put down to indifference which results merely from physical defect.

Beloved Brethren & Sisters in coming among you I deeply feel the responsibility & magnitude

of the undertaking & my own insufficiency thereto, but
 'our sufficiency is of God,' I therefore entreat you to
 sustain me by your earnest and constant prayers &
 to let me have your sympathy & cooperation.

The friends in Neworth are anxious for me to
 remain with them as long as I can, I have ^{therefore} promised
 to stay with them over the 14th Lords Day in November
 & if the vote be concenious to you I hope to begin my
 regular work among you on Lords Day Nov. 29th.
 That we may meet in the fulness of the blessing
 of the gospel of Christ is the prayer of
 yours in the bond of brotherhood & fellowship
