

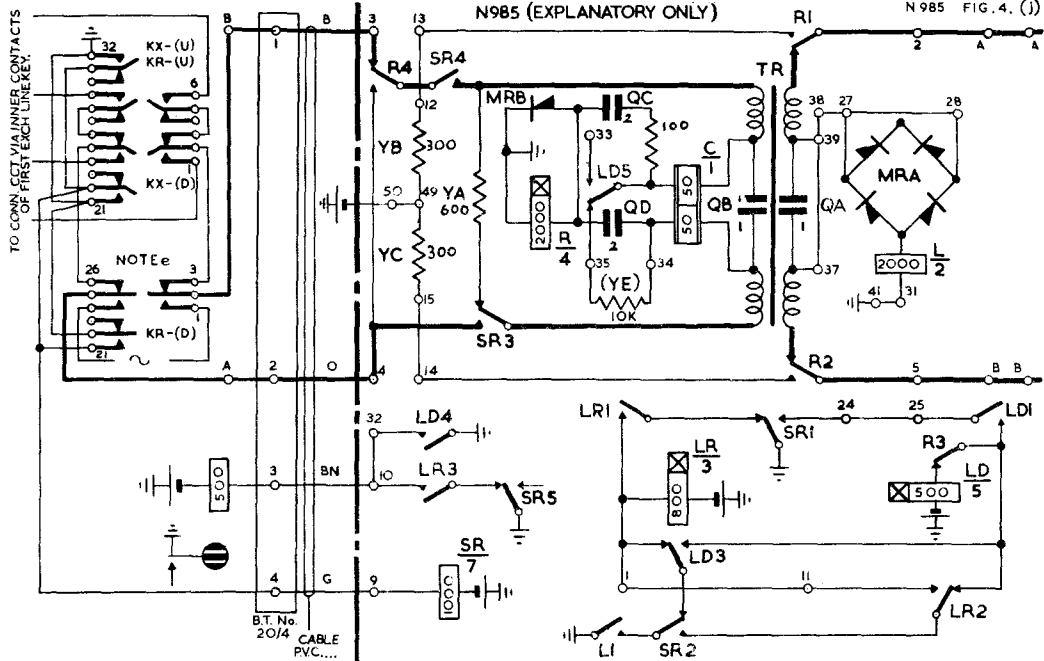
TERMINATION OF INTER P.B.X. PRIVATE CIRCUIT  
SWITCHBOARD CB 935, SIGNALLING GROUP E:G/BAL/BAT B/W

NOTES :-

1. THE INTER P.B.X. PRIVATE CIRCUIT SHOULD BE TERMINATED ON THE FIRST EXTENSION EQUIPMENT.
2. N 705 SHOWS SIGNALLING RESISTANCE LIMITS FOR VARIOUS VOLTAGES.
3. WHERE NECESSARY ADDITIONAL CELLS COMMON TO ALL UNITS, SHOULD BE CONNECTED BETWEEN TAGS 49-50. BATTERY TO TAG 50 S.C. No.121A TO BE WIRED VIA A SPARE NIGHT SERVICE KEY SPRING SET.
4. FOR TRANSMISSION LIMITS SEE E.I TRANSMISSION TELEPHONES B 3590.
5. REQUISITION SEPARATELY:- RESISTOR CARBON No.15GD 10K (YE)
6. "B" SIDE OF HAND GENERATOR TO BE EARTHED

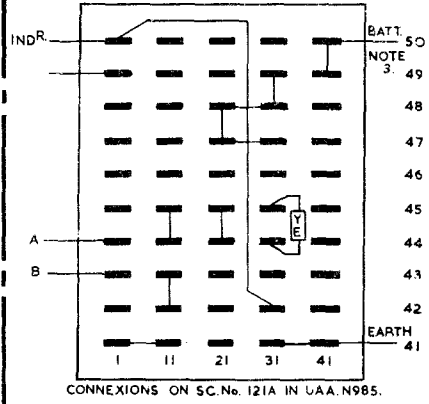
- (A) DISCONNECT WIRE FROM KXA4 AT INDICATOR, PROVIDE WIRE P.V.C. BETWEEN TAG OF INDICATOR TO TERMINAL 3 OF BT No.20/4 (TO BE MOUNTED IN SWITCHBOARD) PROVIDE WIRE P.V.C. 1 PAIR BETWEEN TERMS. A & B ON S/C IN SWBD TO TERMS. 1 & 2 OF BT No.20/4 IN SWBD.
- (B) CABLE BETWEEN BT No.20/4 & UAA N985 USING CABLE P.V.C....
- (C) ALL RECOVERED WIRES TO BE INSULATED & TIED BACK IN FORM.
- (D) WHERE THE SWITCHBOARD IS CONNECTED BY MEANS OF A FLEXIBLE CORD, FIT AN ADDITIONAL B.T. 20/4 ADJACENT TO MAIN B.T. CABLE A & B WIRES FROM MAIN B.T TO THIS B.T. No.20/4, MAKE OTHER CONNEXIONS BETWEEN THIS B.T. No.20/4 & SWITCHBOARD BY MEANS OF 2 OR 4 WAY CORDAGE.
- (E) ON 2+4 & 3+9 RECOVER KRA (KEY No. 171) PROVIDE KEY No. 206
